- Fred to contact Corporate members re: information for Lighthouse. Done
- Explore the possibility of obtaining Corporate members profile from their websites. This will be done as an alternate avenue to obtain Lighthouse news content.
- Fred to contact Colleen O'Meara and Eric McGuiness of *The Hamilton Spectator* regarding World Hydrography Day. Done. There was a negative response from communication. There was a following discussion that highlighted that we shouldn't always hide under CHS and we must do our own thing when we can and this could be an example of that as this wasn't just a CHS issue. Andrew pointed out that he was trying to amend the current communication messaging that referred to Hydrographers as scientists. We are trying to educate and identify ourselves properly.
- Fred to approach Andrew regarding the conflict between the CHA Constitution and the Incorporation By-Laws. Andrew responded that this should be treated as an agenda item at the AGM in June

#### 2. <u>Treasurer Report</u>

A verbal report was presented with a written report to follow. The \$32K in the bank only made 98¢ in interest. This should be addressed. The other accounts are unchanged with several deposits to be made and a cheque to Andrew tonight.

#### 3. <u>Correspondence</u>

#### 4. <u>Committee Reports</u>

a. Admiralty Launch Surveyor. The launch is still tarped and will be checked out in May. There has been a request for a static display around the World Hydrography Day on June 21<sup>st</sup> at the Marine Discovery Centre in Hamilton and also the following weekend at the same venue – Hamilton Ports Day. They have also asked for a water display in late August. There was an invitation for a St. Lawrence

event near Brockville but with no crew responses this is a no. The crew have been invited to the Farm on April 29/30 and a few may go without the launch. Brian did not anticipate any requirement for repairs, just the normal upkeep this spring.

b. <u>Educational:</u> It was suggested that the Lift Bridge Lighthouse Restoration Committee could provide a good speaker for a meeting.

Action: We may be able to get an article from them.

<u>AGM:</u> Scheduled for the same date and place but we do need a speaker.

c. <u>Membership:</u> There are 47 members in good standing at this point. That is broken down as 27 regular members, 3 international, 5 life, 11 corporate and 1 honorary.

It was announced that Jim Statham has been appointed as Director of ACLS.

- d. Web site: Jim was not available to report.
- e. <u>GPS for GIS Course sub-committee:</u> There are over 40 participants and it is going very well.

#### 5. Other Business:

There will be an Executive Meeting next week.

George was very impressed with the turnout tonight – the best in 10 meetings.


