Meeting Agenda Reviewed. Correction: Change date of last meeting to January 26.

1) <u>Minutes</u> of the CHA meeting of 26th January 2006 were circulated and discussed.

Correction: Jeff Walker's tenure as treasurer ended December 31, 2005.

Motion to accept Minutes as corrected: -Moved: T. Janzen/G. McFarlane CARRIED.

Corporate member ACLS is to be transferred from Ottawa Branch to Central Branch. Andrew has requested Atlantic Branch approach UNB and COGS regarding CHA membership. Brian has begun to receive responses from corporate invoices.

Action: Brian to invoice ACLS

The Joint ACLS and CHA publication "Canada's Offshore: Jurisdiction, Rights and Management" is nearing completion. The objective is to have the book released at CHA 2006. The ACLS and CHA logos will be featured on the cover.

<u>Membership</u>: (B. Power) Corporate members have been invoiced. Brian has received four payments to date. Renewal forms were distributed to CHS members. Two individual members who joined late last year should be considered as 2006 members.

<u>Website:</u> (J. Weedon) As of February 16, the Website has been updated for meetings. The possibility of enhancing features on the website was discussed.

Action: Fred to consult with Andrew the issue of conflicts with the Constitution and By-Laws.


Meeting adjourned at 22:48


