Motion: J. Walker/ J. Biggar -CARRIED.

1) <u>Minutes</u> of the 8th December meeting (AGM) were circulated and discussed.

Action: The status of corporate members with Ottawa Branch to be reviewed.

Membership: (B. Power/T. Janzen) Ten members are paid up. Corporate Invoices were mailed out today. George suggested that invoices be sent out to all members. George corresponded with some corporate members regarding potential advertising in the *Newsletter*.

Action: George to follow up with Corporate Members regarding advertising in the *Newsletter*.

Action: Membership Committee to determine the status of Corporate Membership of ACLS in CHA.

<u>Lighthouse</u>: (J. Weedon) The Fall edition is behind schedule but should be out to the printer by end of February. Jim is looking for volunteer support to assist him with this task.

Website: The Website is updated as of today (Jan 26^{th}).

National President's message: (A. Leyzack) Andrew was unable to attend however he prepared a synopsis for review. Fred read Andrews message. The message reviewed the current situation of the CHS, *Lighthouse* and IFHS membership. A motion was made by

Andrew for CHA to explore the benefit of a *Hydro International* subscription, subsidized for 2006 by CHA National. *Hydro International* annually publishes ten issues and Andrew feels that it could be an excellent value added benefit to the membership. George feels that we should explore other avenues before we consider the option of canceling *Lighthouse*. Heimo feels that further clarification is required from the National President on this issue. The motion was sent back for further clarification.

A suggestion was made to obtain three subscriptions to *Hydro International* for circulation to CHA members within CHS, outside CHS and for the Gerry Wade Memorial Library.

Action: Fred to investigate the proposal of three subscriptions to *Hydro International* vs. a single subscription.

5) Other Business: George suggested an Honorarium be offered to individuals who volunteer to work on *Lighthouse*.

George indicated he would support paying a professional to assemble Lighthouse as a last resort.

Action: Fred to inform Andrew that Central Branch would like to review options for *Lighthouse* and solicit feedback from other CHA branches.

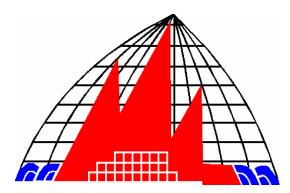
Meeting adjourned at 20:20.
