



 $\frac{Treasurer's\ Report:}{Lighthouse\ was\ pointed\ out\ ('t'\ missing)}.\ The\ separate\ account\ for\ Lighthouse\ has\ been\ closed\ following\ the\ retirement\ of\ Rick\ Sandilands\ who\ maintained\ the\ account.\ Membership\ dues\ from\ March\ were\ deposited\ this\ month.\ The\ H_20\ Bonspiel\ accounts\ were\ settled\ this\ month.$

Motion to accept the report:

3) <u>Correspondence</u>: (F. Oliff) Fred has been in correspondence with Peter Knight of the University of Otago, scheduled to speak to us at our May meeting. Peter will discuss the university receiving IHO Category "A" accreditation for their Hydrography programme. The venue, originally scheduled for Cambridge, has been changed to CCIW in one of the seminar rooms. It is thought that this may be of wider interest and that more people will attend if it is held locally. We can have the event catered by the cafeteria, and hold it around 1400 hours.

4) Committee Reports:

Admiralty Launch Surveyor: (B. Power) There will be a static display of the launch this spring, May 7-9 at Upper Canada Trade Faire at Odessa. Surveyor will be left there and then picked up on the way to Ottawa for the conference. A work party for maintenance was struck at the meeting held last week at the Power residence. At the CHC 2004 in Ottawa, it is anticipated that the launch will be a water exhibit with the other survey vessels, set-up on the Monday and return on

the Friday (May 24th and May 28th respectively). E. Brown, K. Dexel and J. Dixon will meet up with Ottawa branch member J-M. Gervais and will form the basis of the crew.

The sail-training event in Kingston in June is full; it is in conjunction with the *St. Lawrence II*, mainly attended by members of the militia. P. Rindlisbacher is taking his boat, but the Surveyor will not attend.

<u>Meetings:</u> (T. Janzen) Peter Knight will speak about University of Otago (NZ) getting IHO Category "A" accreditation on May 20th at CCIW at 1400 hours.

CHC2004: (A. Leyzack) There will be a CHA booth outside the entrance to promote the CHA and Lighthouse. Ottawa branch members S. Kirkpatrick and I. Monahan will sell beer mugs, CHA caps (some of which will also be available to the general membership). These caps are presently being designed and are being made for the multibeam course, held during the week preceding the conference. The course has presently twenty-five people signed up. The CHA is sponsoring Steve Ritchie to attend the conference. Steve, along with others, co-authored a book, which will be launched at the conference.

<u>Gerry Wade Library:</u> (T. Janzen) The most recent acquisition for the library is "GPS Theory and Practice". Part of the agreement in our getting this book is that we do a review for Lighthouse. It is hoped that we can get Ahmed El-Rabbany or Dave Wells to do the review.

The sequel planned for The Chartmakers is being prepared by CNRS.

<u>Membership</u>: (B. Power) There are currently 55 paid-up members of Central Branch. This includes 15 in-house, 19 out-of-house, 8 international, 4 life and 9 Corporate members.

Web-site: (J. Weedon) No report was available.

5) Other Business: (T. Janzen) A. Leyzack reported that new members have been appointed to the CIG Hydrography Committee, with representatives from academia and the marine industry. An extensive list of nominations was sent out, and everyone agreed to stand. This list was whittled down according to a number of factors, including regional representation. The following members were appointed to two-year posts on the panel: from industry John Brigden (Brigden Surveying Consulting), Brian Pyke (Centre Of Geography Sciences), Peter Tobin (College of the North Atlantic) and Susan Scone (University of Calgary).

Tim reported that the hats (discussed before) were originally ordered for the multibeam course but that additional hats were being ordered for membership. The CHA crest (2" in diameter) will be embroidered on the peak. It is hoped that follow-up orders will help pay for the tool-up fee, which only applies to the first order.

The \$300 travel subsidy for CHC2004 will be awarded to the member from Ghana. Treasurer J. Walker will present the cheque. Responses to this idea were generally positive.

On the subject of the digital newsletter, about two dozen responses were also positive. One suggestion that it should be in PDF format will be looked at as Tim will now try to procure the software needed to do this. "Miss the stamps" was a comment heard a couple of times from members.
